Factory applied and available through River City Wood, Renovare™ is an organic-based blend of food grade chemicals for industrial and commercial use.

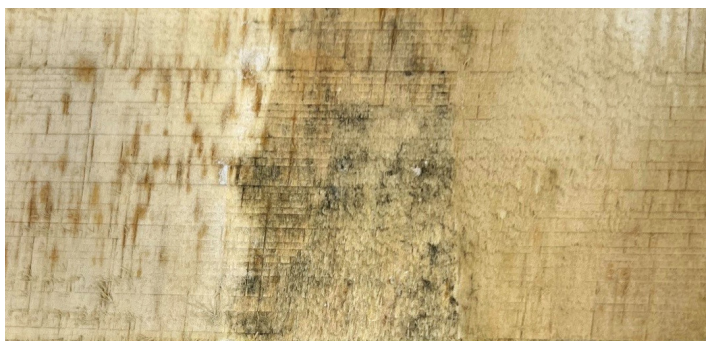
Product Storage

Store away from other materials in a corrosive resistant container with a resistant inner liner. Protect from sunlight. It is recommended to store Renovare™ at temperatures where the bulk liquid will not exceed 86°F / 30°C. Keep cool. Store locked up.

Product Disposal

Dispose of contents and containers at an approved waste disposal plant according to state and local regulations. Do not contaminate water, food, or feed by storage and/or disposal.

Directions for Use

Read product label before using.

Renovare™ may be applied to wood and wood products by spray methods. It may also be applied in a backpack or tank sprayer as a dilute solution when mixed with water in a contained and well-ventilated area. Dilutions can be adjusted based on the severity of mold and mildew staining, and weathering. Brushing or scrubbing may be required for exceptionally weathered or stained material.

For spray applications:

Mix one gallon of Renovare to 1-50 gallons of water.

For wood products whose appearance has been affected by mold, application of Renovare™ will help clean the wood and maintain the appearance for some time.
